



## DECLARATION / INDEMNITY FORM FOR CARRIAGE OF PETS

I..... being the registered owner of the pet travelling, request Air India to:

- To transport my pet from the origin to the destination as mentioned below; and
- Arrange at my cost any veterinary services and/or assistance to the pet in the case of illness, or as reasonably deemed by Air India to be necessary for the well-being of the pet during the journey; and
- I am responsible for determining whether the pet is pregnant or not and is not suitable to travel on the journey for which I am lodging the animal for carriage; and
- I am not aware of any reason that the pet should not undertake the intended journey, such as ill-health or aggressive behavior that may put the pet or others in danger; and
- I will comply with all documentation required for carriage of pets in cabin as per Air India requirements and/or country regulations, applicable laws, including Government Quarantine Regulations which govern the importation and exportation of animals; and
- I will ensure that the Animal's cage or transportation container complies with all regulatory requirements and requirements of the Air India, including in relation to size so that the animal has sufficient room to stand up, turnaround and lie down without restriction; and
- I understand and accept that the transport of the animal by air has inherent risks, including an increased risk of mortality, and that environmental conditions such as temperature and humidity levels may have a significant effect on the health and well-being of the pet; and
- I acknowledge that Air India strongly recommends that brachycephalic animals (e.g. short-head breeds) or other animals that are prone to breathing difficulties are not lodged for transport if temperatures may exceed 20 Degrees Celsius at any point of the journey; and
- I acknowledge that the pet will not be accompanied or supervised by airline employee, or its authorized agent and I accept that the Airline may not have the expertise or ability to access veterinary services or identify risks to health or well-being of the pet throughout the journey.

I also undertake to bear any losses, costs or expenses that may arise (directly or indirectly) in connection with:

- a) any failure to comply with my responsibilities outlined above, including to the extent the failure contributes to any injury to or death of the pet; and
- b) the pet breaking out of its cage or container, including any personal injury or property damage suffered by Air India, its personnel or any third party.

I agree that Air India reserves the right to refuse the carriage of pet(s) and will not be responsible –

- a) for incidental, special, or consequential damages, including but not limited to damages for emotional distress and other non-economic loss in connection with the animal or its carriage.
- b) if authorities in other countries refuse entry to my pet due to non-compliance with local regulations. Air India will in this case, not be liable for any resulting costs such as flight rebooking charges, hotel accommodation if Air India have to refuse the carriage of my pet due to non-compliance with the regulations.

In full knowledge of the Term's & Condition's set above, I request Air India to transport the pet/s from the origin to destination as detailed below.
